Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. • The Farmers Bank does not share with our affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial companies and nonfinancial companies. • The Farmers Bank does not share with nonaffiliates so they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • The Farmers Bank doesn't jointly market.
